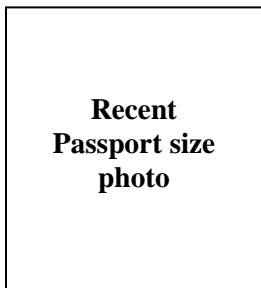

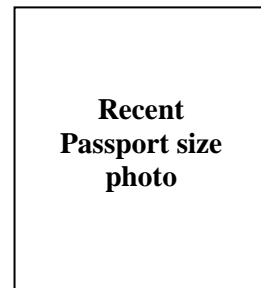

RULES AND REGULATION

A. The Tournament Guidelines

The Rules and Regulations of the Tournament will be based on Badminton World Federation rules.

A. Event Categories

- Under 13 years old (BS,GS)
- Under 16 years old(BS,GS,BD,GD)
- OPEN (BD,GD)

B. Eligibility

- The Tournament Organizer reserves the right to dissolve any level without a minimum of 8 pairs.
- Players must submit a NSO authenticated birth certificate.

C. Tournament Format

- The tournament shall use a single elimination format in all events.
- Each participant(s) can join up to two (2) events.
- After the toss has been conducted, the players will be given two (2) minutes to warm-up.
- Decisions of the Umpire, line judges and table officials' shall be final.
- In case of an injury, the player will be given first aid, depends on the advised of assigned Medical Team.

D. Scoring System

- A BWF scoring system 3 x 21 rally point will be use in all events.

E. Rules on Substitution

- A pair can only substitute a player before the start of the tournament; line-up of players is final once the tournament has started.
- Manager's Meeting & Draw
September 18 at 4:00 PM.
Please note that non-attendance of the Manager's Meeting means that Team Manager and Players are agreeable to all the guidelines and rules drawn during the meeting.

F. Rules on Defaulting

Players will be given a **three (3)** minutes defaulting time; if the players do not arrive within the allotted time, the game will be declared a walk-over and the present player will be declared winner.

G. Protest

Protest or question regarding the age of the participants will be accepted with corresponding letter with proof of evidence and fee amounting to Ph 2,000.00.

H. The Tournament Organizer / Director reserve the right to accept or deny any entry, it deems necessary with proper justification.

I. The technical committee has the right to disqualify any participants for the ff reason Misconduct, dishonesty and falsification of documents.
